ROSEBUD SIOUX TRIBE RESOLUTION NO. 2012-343

- WHEREAS, the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and
- WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-Laws; and
- WHEREAS, the RST Education Department is a duly authorized department organized in accordance with Ordinance #91-04, The Rosebud Sioux Code of Education, for the purpose of administering the Code and providing administering services for education programs of the Rosebud Sioux Tribe; and
- WHEREAS, the Rosebud Sioux Tribe Education Department has recommended the Rosebud Sioux Tribe adopt the official Sicangu Lakota Language Orthography that has been developed by the Rosebud Sioux Tribe Lakota Language Advisory Council made up of Lakota speakers instructors and elders from the community and Sinte Gleska University. This Orthography will meet the needs of students to include all known sounds in the Lakota language to effectively speak, read and write the Sicangu Lakota language; and
- WHEREAS, The Rosebud Sioux Tribe has adopted the Official Sicangu Lakota Language Orthography ("the art or technique of correct spelling according to established usage") as recommended by the Rosebud Sioux Tribe Education Department; and

THEREFORE BE IT RESOLVED, the Rosebud Sioux Tribe hereby adopts the Official Rosebud Sioux Tribe Lakota Language Orthography recommended by the Rosebud Sioux Tribe Education Department; and

BE IT FURTHER RESOLVED, that the Rosebud Sioux Tribe hereby directs the Rosebud Sioux Tribe Education Department to implement the Official Rosebud Sioux Tribe Lakota Language Orthography.

CERTIFICATION
